FROM THE DESK OF DEAN STUDENTS' WELFARE





INTERNSHIP PLACEMENTS



At the Department of Laws, Guru Nanak Dev University, Amritsar, we believe that a degree is not just a theoretical achievement. We strive to ensure our students gain practical exposure through internship placements, enabling them to learn, grow, and apply their knowledge in real-world scenarios.

This facility of providing internships has been inculcated from past 1.5 years. Students take up these internships to gain first hand experience of the legal world, some start as early from the first year of their three year course or the second year of the five year course.

This year, The students had the opportunity to intern at the District court Amritsar and the Advocate general Punjab's office, Punjab and Haryana High court Chandigarh. They were placed under the supervision of eminent judges and respected lawyers.

Even on 'No Work Days' the advocates dedicated the time to have discussions and clear all doubts to ensure a strong foundation in litigation basics.

The final-year law students attended the compulsory civil court training at the District and Sessions Court, Amritsar, as part of their legal curriculum. This training offered students invaluable hands-on experience by allowing them to observe real court proceedings, interact with legal professionals, and understand courtroom procedures in practice. As a part of this exercise, all students prepared an advocate's diary—a detailed record of the client interviews, various cases and the important steps of the legal proceedings. They also had exposure to legal proceedings of other adjudicating authorities, like the arbitration and mediation proceedings as well as The Sikh Gurdwara Judicial Commission, Amritsar.

WORKSHOPS & SEMINARS

NATIONAL SEMINAR ON THE SOCIO LEGAL IMPACT OF DRUG ABUSE:

On March 31, 2023, the Department of Laws held a national seminar titled "Socio-Legal Impact of Drug Abuse: Addiction and Awareness," which was conducted in both online and offline formats. The seminar was coordinated by Dr. Shikha Dhiman and Dr. Manjit Singh, who facilitated engaging discussions among participants on the pressing issues surrounding drug addiction and its societal implications. Esteemed speakers from legal, medical, and social work backgrounds contributed their insights, emphasizing the importance of awareness and education in combating drug abuse. The event aimed to foster a collaborative environment for sharing research findings and strategies to address the challenges posed by addiction, ultimately advocating for enhanced legal frameworks and community support systems. Participants left with a deeper understanding of the socio-legal dimensions of drug abuse and a commitment to raising awareness in their respective fields.

NATIONAL WORKSHOP ON COMBATTING STRESS AMONG YOUTH

On April 3, 2024 the Department of Laws conducted a one-day national workshop titled "De-Stress and Not Distress: Combatting Stress Among Youth." The workshop featured Dr. Neeru Atri, Head of the Department of Psychiatry at Government Medical College, Amritsar, as the Guest of Honour, alongside resource person Dr. Khushbinder Singh, Assistant Professor in the same department. Co-ordinated by Dr. Shikha Dhiman, the event aimed to address the growing issue of stress among youth, providing valuable insights into effective coping strategies and mental health awareness. Participants engaged in interactive sessions and discussions that highlighted the importance of mental well-being and the role of educational institutions in supporting students. The workshop successfully equipped attendees with practical tools to manage stress, fostering a culture of resilience and proactive mental health practices.

MADHYAM — MEDIATION IN ACTION

The Department of Laws, Guru Nanak Dev University, Amritsar, successfully organized the Madhyam'23 – First Intra-department Mediation Competition on 8-9 November 2023. The event aimed to promote and enhance mediation skills among law students, offering them an opportunity to engage in practical dispute resolution. The competition was inaugurated on 8th November by Dr. Pawan Kumar, Head of the Department, who emphasized the importance of alternative dispute resolution in modern legal practice. Eighteen teams, each consisting of three members—client, counsel, and mediator—participated in the competition. The event comprised four rounds: preliminaries, quarter-finals, semi-finals, and the finals. The first three rounds were judged by esteemed faculty members, while the final round was presided over by Adv. Harvinder Singh Chauhan, whose expertise added a distinguished touch.

The competition was meticulously organized by the Moot Court Committee, with Faculty Coordinator Dr. Harkirandeep Kaur overseeing the event. The winners of the competition were Anirudh Arora, Sahana Bhandari, and Bhuvan Pali. The runners-up were Raveesh Mahajan, Shvinder Singh, and Devika Sharma, while the Best Counsel award went to Shvinder Singh, the Best Client award to Sahana, and the Best Mediator award to Anirudh Arora. The prize distribution ceremony, held on 9th November, was graced by Dr. (Prof.) Preet Mohinder Singh Bedi, Dean Students' Welfare, Guru Nanak Dev University, Amritsar, who served as the Guest of Honour. The event was a significant success, contributing to the development of essential skills in the field of mediation and providing a valuable learning experience for all participants.

THE LEGAL LITERACY WEEK

THE DEBATE COMPETITION

On February 19, 2024, the Moot Court Committee organized a Debate Competition as part of Nyay Utsav'24 - the Legal Literacy Week, aimed at nurturing critical thinking and public speaking skills among students. The competition featured discussions on important legal topics, including the Uniform Civil Code, Interim Budget, and the Right to be Forgotten vis-à-vis Right to Privacy.

A total of 20 students participated in the competition, which consisted of four rounds. Each participant was given 90 seconds to present their arguments, followed by a 1-minute rebuttal. A panel of faculty judges evaluated the participants based on content, argumentation, rebuttals, clarity of expression, and adherence to debate etiquette.

The competition concluded with Raveesh Mahajan securing the First Position and Anirudh Arora taking the Second Position. Certificates of participation were awarded to all participants in recognition of their efforts, contributing to the success of the event.

THE QUIZ COMPETITION

The Legal, as well as General Knowledge, is one of the most substantial elements in any law student's life. As part of our Legal Literacy Week, **Nyay-Ustav**, The Quiz Competition was a huge success. The event witnessed enthusiastic participation from 32 students from various years of the law program, who competed in a challenging three-round competition designed to test their legal acumen. The quiz format progressed from a cloud-based preliminary round of 100 objective questions to an interactive semi-final featuring rapid-fire questions and visual rounds, surmising an intensive final round that challenged participants with legal scenarios, questions on constitutional, Contract, Family, and tort law, along with analysis of landmark Supreme Court judgments.

Drishti, a final-year student (class of 2024) won the competition. She and her team won the First Intra-Moot Court Competition as well. Anirudh (First year) and Devika, (Second year) followed as the second and third positions, respectively.

The organizing committee's integration of technology for scoring and presentation, combined with practical scenario-based questions, received appreciation from participants and faculty members, while also setting a new standard for future legal literacy initiatives in the department.

CASE-ANALYSIS COMPETITION

The Department of Law held its Case Analysis Competition on **February 21, 2024**, involving students from BA.LLB (FYIC), LLB, and LLM programs. Participants were required to analyze a legal case spontaneously, without prior preparation, to enhance their critical thinking, legal reasoning, and communication skills. The case focused on Articles 21, 13, 32, and 226 of the Indian Constitution.

The Head of the Department, inaugurated the event, emphasizing the importance of practical legal skills. Participants were evaluated by a panel of judges from the faculty. The standout presentations by Ridhima and Janvi, who skillfully referenced laws and judgments, earned them certificates of appreciation.



THE MOOT COURT COMPETITION

The Moot Court Competition at the Department of Laws, Guru Nanak Dev University, provided students with a vital platform to develop advocacy skills and gain practical legal experience. Participants represented either the appellant or appellee, presenting cases through written briefs and oral arguments. The event followed a structured format, beginning with preliminary rounds where teams showcased their legal expertise. Teams were judged on both their written submissions and oral presentations, evaluated by a panel of esteemed faculty members. The final round was presided over by a special judge, adding prestige to the competition. The moot proposition focused on the legality and recognition of prostitution under Article 19(1)(g) of the Indian

Constitution, requiring the participants to explore the balance between fundamental rights and public morality. Four teams advanced to the quarterfinals, with two teams moving on to the final round. The winning team, composed of Drishti, Paras, and Isha, took first place, while Muskan, Aishwarya, and Avneet were the runners-up. Muskan won Best Counsel, and Rishita was awarded Best Researcher. The competition was well-organized, with the Department of Laws ensuring smooth execution and maintaining high academic standards. Overall, it was a resounding success, providing a memorable and enriching experience for all participants.



WEBINAR ON TRANSFORMING LEGAL AID IN INDIA

On February 27, 2024, the "Nyay-Utsav" webinar concluded Legal Literacy Week, co-ordinated by Dr. Harkirandeep Kaur and Dr. Manjit Singh via Google Meet. The event centered on "Changing the Dimensions of Legal Aid in India," with Dr. Kanchal Gupta, Associate Professor at UPES, Dehradun, as the keynote speaker. Dr. Gupta explored the evolution and challenges of legal aid, emphasizing the need for innovative approaches to improve accessibility. She discussed the role of legal aid clinics, paralegals, and technology in bridging gaps between marginalized communities and the legal system. The webinar fostered lively discussions on enhancing legal aid and urged collaboration with legal aid clinics. Participants left empowered, reflecting on the need for ongoing efforts.

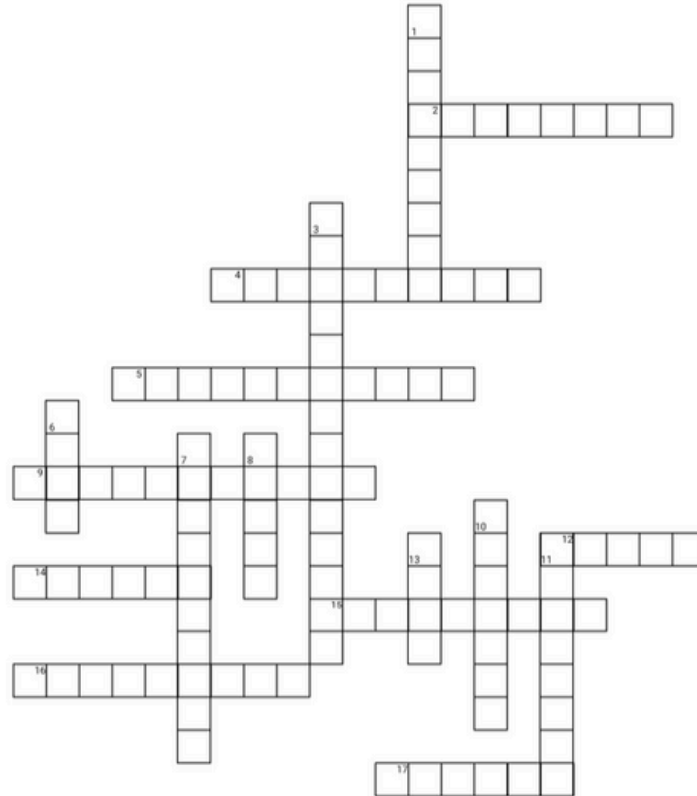

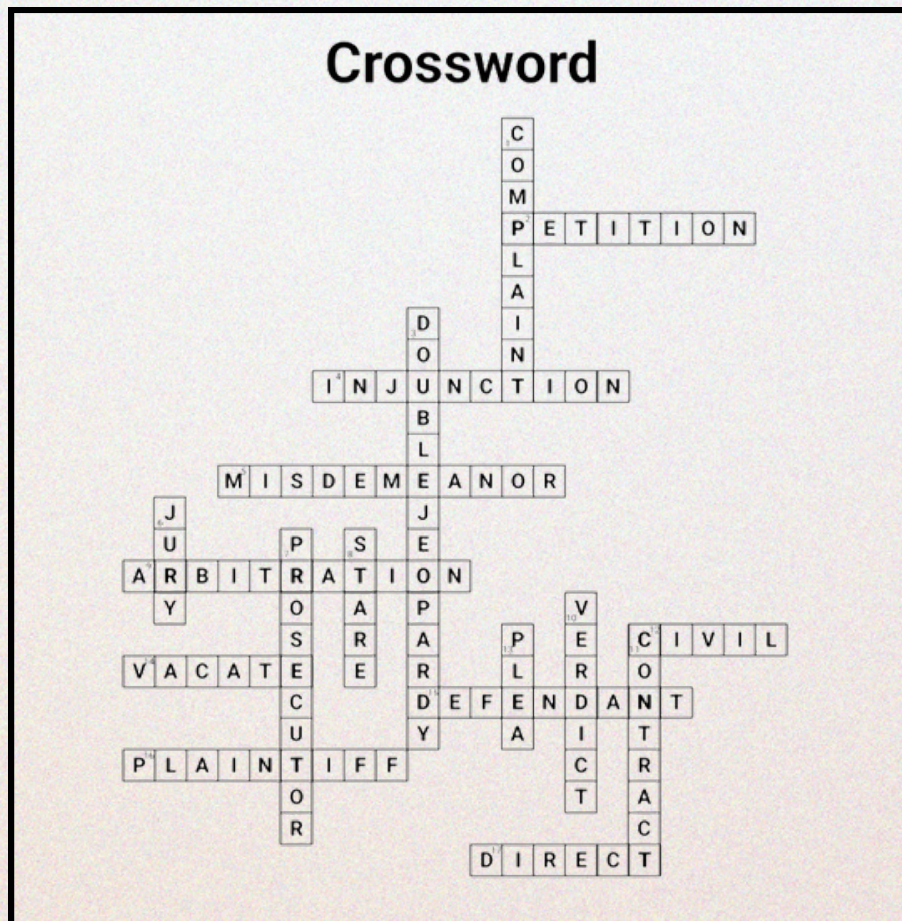

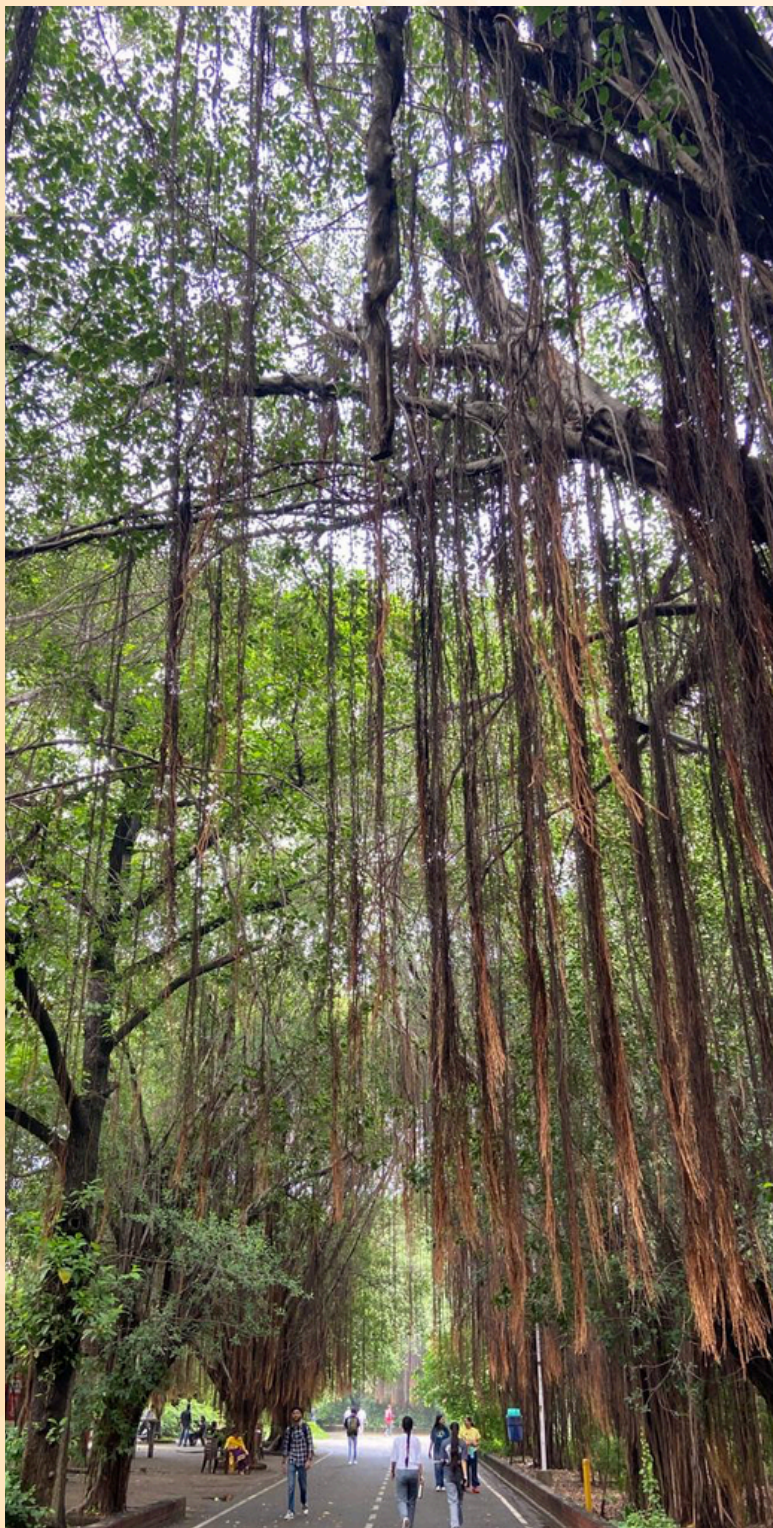
